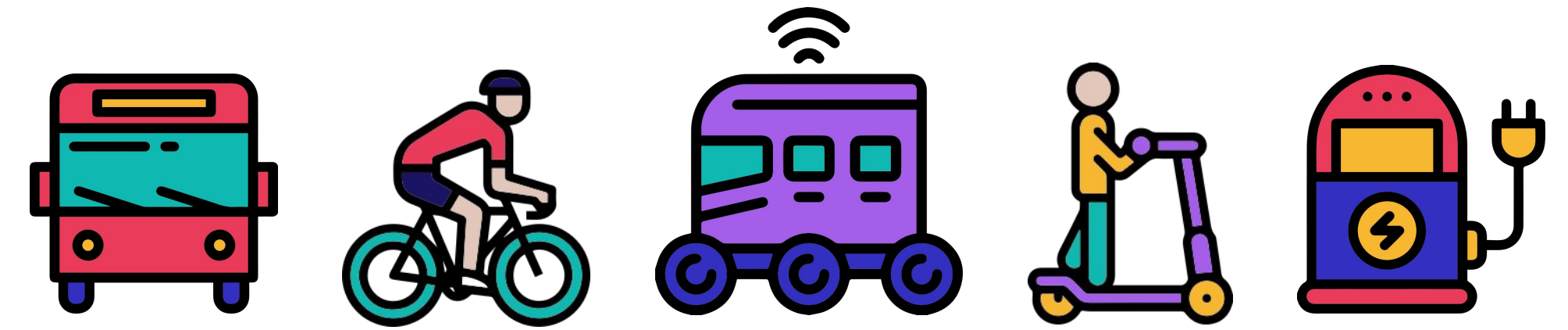

Autonomy Mobility Startup Challenge

What is it?

Now in its 5th year, the **Autonomy Mobility Startup Challenge** – formerly known as **Funding the Movement** – recognises and celebrates startups that are bringing new innovations and enabling transformation in the mobility sector. It is open to startups less than 7 years old presenting projects, products, solutions, ideas, or prototypes focusing on any of 7 Industry Themes in our mobility ecosystem.

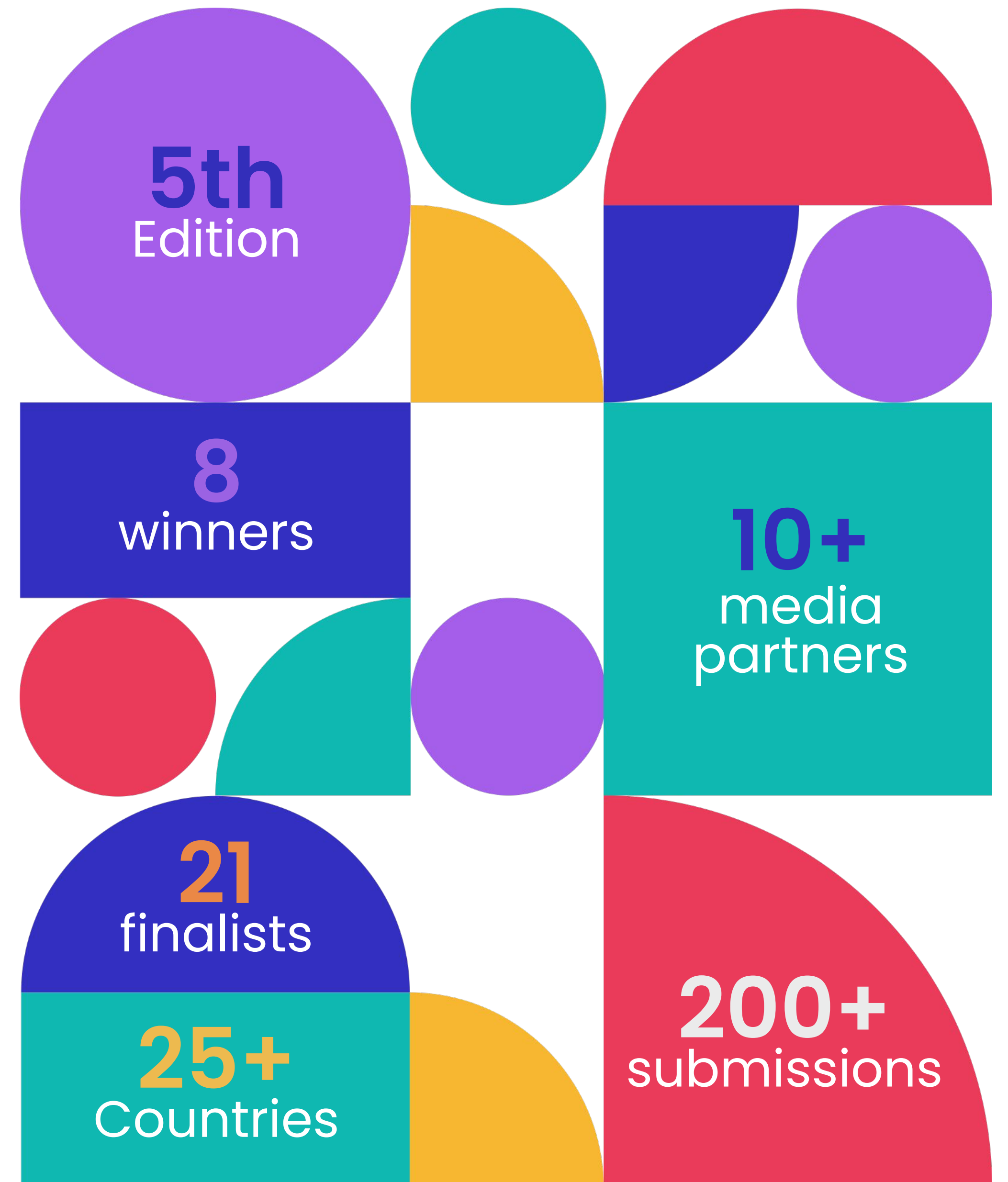
Where is it?

The challenge takes place during **AUTONOMY MOBILITY WORLD EXPO 2023**, at **Pavillon 6, Porte de Versailles** on **22nd and 23rd March 2023**.

How does it work?

21 startups will be pre-selected to pitch (3 from each Industry Themes), and **8 winners** will receive a prize with international recognition (1 from each Industry Theme, and 1 overall winner from the Public).

A prestigious jury composed of mobility investors, strategic mobility players, and partners of Autonomy will review and select the best projects.

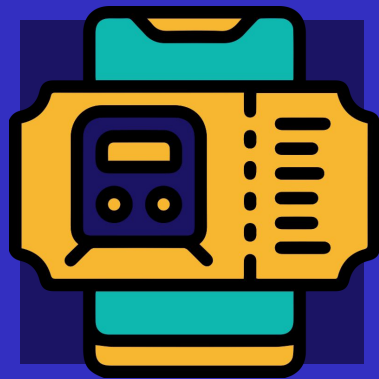


7 Categories



1. Smart Mobility Cities

Re-engineering cities for the shift from motorist to mobilist; includes the expansion of mass transit and the infrastructures for connected, autonomous, shared, and electric vehicles.



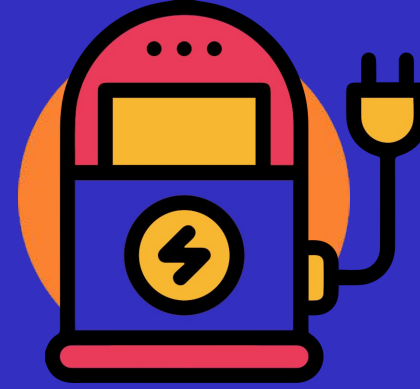
2. Mass Transit

The backbone of Smart Cities Mobility; complements active and shared mobility and is the best solution for moving large numbers of people quickly.



3. Active Mobility

Shares the streets with multiple modes of mobility; includes walking, cycling, micromobility, and other human-powered vehicles.



4. EV Fleets

Corporate fleets are going green with companies switching from ICE to EV; fleet managers need to understand assisting EV purchases, charging infrastructure, and optimizing driving through route planning and telematics.



5. Shared Mobility

Comprised of car, bike, and scooter sharing; encompasses the hardware, software, and services used by shared mobility operators.



6. Urban logistics

How to complete the “last mile” while saving time and costs; includes cargo bikes, delivery robots, LEVs, and other hardware, as well as the software that manages fleets, parcels, and pickups.



7. Autonomous Vehicles

Needs to be integrated with mass transit and shared services; constitutes driverless trains, trams, buses, shuttles, and, cars as well as the hardware and software that enable autonomous mobility.

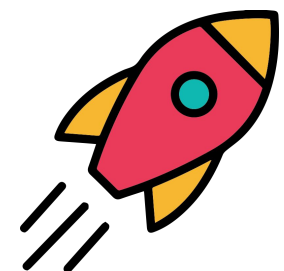

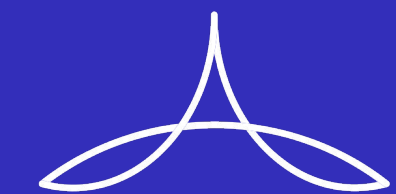
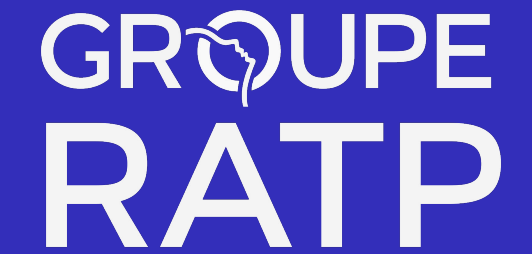

Then join the Startup Challenge! Autonomy and its partners invite you to submit your application to the AUTONOMY MOBILITY STARTUP CHALLENGE 2023. This is a unique opportunity to actively be a part of shaping the future of our cities.

The Challenge is open to startups less than 7 years old presenting projects, products, solutions, ideas, or prototypes focusing on any of 7 Industry Themes of the Mobility ecosystem. The company should be officially created with at least 2 people and from any country of the world.

Finalists will be invited to Autonomy Paris on March 22-23, 2023 to pitch in front of a jury and the global audience of city officials and major mobility players participating in the event.

What Will You Receive?

All Applicants

- ✓ All startups submitting their project will be automatically selected to join the Startup Village with a free participation in the Startup Village networking lounge (open space for all startups + logo visible within the Startup Village Lounge).
- ✓ All applicants' company logos will be listed on the website.
- ✓ If a startup wishes to have an individual stand, all applicants will benefit from a 5% discount on the startup booth starting from 1250€ excl taxes or a 9m2 stand at 6000€.

21 Finalists

- ✓ The 21 finalists will be announced within our entire community with a press release planned for February 2023, on the website, within our newsletter and on social media channels.
- ✓ All finalists will get a small stand in the Startup Challenge finalists area in the Startup Village.

8 Winners

- ✓ The 8 winners of the 2023 edition will receive a free startup stand in the next edition of the trade show in 2024 (or a discount of 1250€ excl. taxes on a 9m2 stand).
- ✓ They will also receive an article in our e-newsletter (content to be provided) and an individual social media announcement presenting the winner of each category.
- ✓ The winning startups can also benefit from special coaching and supporting options given by the Challenge partners.

Terms & Conditions

This document sets out the rules of the Autonomy Mobility Startup Challenge. It constitutes a binding agreement between the company applying to the Autonomy Mobility Startup Challenge (the “Applicant”) and Autonomy.

1. Organizer

The Autonomy Mobility Startup Challenge is organised by Autonomy, a French company (SAS) headquartered in Paris.

2. Applications

The Autonomy Mobility Startup Challenge recognizes startups that are bringing new innovations and enabling transformations in the Mobility solutions industry. It is open to startups of less than 7 years old presenting projects, products, solutions, ideas or prototypes or solutions focusing on any of the 7 Industry Themes of the Mobility ecosystem.

The text of all applications will be referred to by the Autonomy team. The Autonomy Team reserves the right to reject any submission that does not meet its evaluation criteria. The inclusion of the application in the Challenge will also be dependent upon:

1. The submission of the application by the official deadlines;
2. The content of the application;
3. The company representative who will be present the pitch
4. Startups may only submit themselves for up to 2 Industry Themes but the presented solutions should be distinct

3. Selection process

A prestigious jury composed of investors, incubators and partners of Autonomy will review and select the best projects. The Jury can change during the process. The jury deliberations will be confidential. All decisions of the jury are final and cannot be appealed. Team reserves the right to ask for any clarification or additional information about the submitted entries.

Key dates

September 15, 2022: Registration opens and submission of applications

November 30, 2022 : Registration closes

February 1, 2023 : Announcement of finalists

March 22-23, 2023: Pitch competition during Autonomy Paris

8 Winners announcement (jury - 7 categories + public Vote)

4. Data

In order to review the applications, Autonomy will collect the Applicant’s data. By accepting the terms and conditions, the Applicant allows Autonomy to use the data in the context of the challenge, both for its organization and promotion. The Applicants allows Autonomy to send their application file and Data to the jury members in order for them to review and assess their application. Autonomy is authorised to publish the logos of participants online and onsite and to announce the finalists.

5. Confidentiality

Autonomy guarantees the Applicant the full confidentiality of all information communicated during the Startup Challenge and ensures that the jury will maintain the same level of confidentiality. Main jury members will have access to all datas and infos of all candidates.

6. Cancellation of the Challenge

Autonomy may cancel the Challenge at any time. If so, applicants will be informed by email.

7. Costs

All costs relating to participation, including travel, accommodation and subsistence will be covered by the applicant.

8. Costs and travel processes

To enter your submission, the applicant needs to fill in the form available online. Proposals must be submitted electronically via the [Autonomy website](#) and must conform to the terms and conditions. The form and all complementary information will have to be filled out entirely in English. No applications in any other languages will be accepted. The Autonomy Team reserves the right to ask for any clarification or additional information about the submitted entries.
